MEN'S TREATMENT PROGRAM: THE MEN'S RESIDENTIAL TREATMENT PROGRAM IS A 12-MONTH, FAITH-CENTERED, 12-STEP SOCIAL MODEL PROGRAM. RESIDENTS ARE PROVIDED WITH A LIVING AND LEARNING ENVIRONMENT THAT ADDRESSES THE ISSUES OF ADDICTION IN A HOLISTIC WAY. THE PROGRAM'S CORE TENET IS THAT RECOVERY OCCURS IN RELATIONSHIPS WITH GOD, OTHERS, AND SELF. THE 12-MONTH DURATION OF THE RESIDENTIAL PROGRAM ALLOWS INDIVIDUALS SUFFICIENT TIME TO STABILIZE, REFLECT AND ADDRESS DEEPLY-INGRAINED BEHAVIORS, THINKING AND CONSEQUENCES OF YEARS OF ADDICTION. INTENSIVE CASE MANAGEMENT, INDIVIDUAL COUNSELING, GROUP FACILITATION, INDIVIDUALIZED EDUCATION AND VOCATIONAL TRAINING INCREASE THE LIKELIHOOD OF TREATMENT COMPLETION AND, ULTIMATELY, LONG-TERM RECOVERY.

SHELTER IS PROVIDED EVERY NIGHT FOR APPROXIMATELY 94 MEN AND 39 WOMEN. FOR THE YEAR ENDED SEPTEMBER 30, 2021, THE MISSION PROVIDED APPROXIMATELY 48,000 MEALS AND 20,000 OVERNIGHT STAYS FOR THE HOMELESS OF SANTA BARBARA.
